

## IMMIGRATION – INVESTOR VISAS

---

The Tier 1 (Investor) category is for high net worth individuals making a substantial financial investment in the UK.

### Who is eligible?

#### *Investment requirements*

- Applicants with £2m of their own funds to invest in the UK
- Funds must be held in a UK or overseas-regulated financial institution
- Must have opened an account in a UK regulated bank for purpose of investment
- Funds must have been available to applicant for > 2 years before date of application OR further evidence of source required
- Must have control of funds- Home Office can investigate provenance of funds

#### *Additional requirements*

- Must be over 18 years old
- Overseas criminal record certificate required for each country spent > 12 months (continuously OR cumulatively) in 10 year period preceding the application
- No adverse immigration history

### Benefits of an Investor Visa

- Unrestricted right to self-employment and employment in the UK\*
- Accelerated route to permanent right to live in the UK (Indefinite leave to remain)
- No English language requirement
- Can bring dependants

### Time-scale, fees and period of grant

- Average decision making time is 3 weeks
- Home Office Fee - £1623
- Immigration Health Surcharge - £1400
- Initial visa granted for 3 years and 4 months

### Main requirements to extend initial visa

- Applicants must invest £2m within 3 months
- Investments must be maintained at £2m or visa curtailed (cancelled)
- Portfolio must be managed by FCA regulated financial institution

### How to acquire permanent right to live in the UK

- 2 years residence required if have invested and maintained £10m or more in the UK in accordance with the rules
- 3 years residence required, if have invested and maintained between £5m and £10m, or
- 5 years residence required, if have invested and maintained between £2m and £5m.
- Meet rules on absences
- Meet English language requirements
- Pass Life in the UK test
